



# Notice of Race

### 2017 Fall Series Regatta and Leukemia Cup

September 23, 24, 30 & October 1, 2017

#### **1 RULES**

- 1.1. The regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS).
- 1.2. RRS Appendix T shall apply.
- 1.3. The US Sailing Prescription Appendix V, Rule V1 shall apply.
- 1.4. The US Sailing Prescriptions to rule 63.2 shall not apply.
- 1.5. Minimum Equipment Recommendations of the YRALIS (Category C).
- 1.6. IRC Rule 22.4.2 will be changed to include the following: Yachts may carry one additional crewmember less than 14 years of age, and such additional crew member shall not be counted against the Crew Number or crew weight limitations. Entrants who intend to carry an additional crewmember less than 14 years of age must so indicate by email to [aycrc@americanyc.org](mailto:aycrc@americanyc.org) no later than 1800 on Friday, September 22, 2017.
- 1.7. Rule 51 will be changed to allow the use of a canting keel and Rule 52 will be changed to allow the use of stored power for the mechanism to cant the keel.
- 1.8. Rule 61 will be changed to require boats to notify the Race Committee immediately after finishing of their intent to protest.

#### **2 ELIGIBILITY**

The regatta is open to offshore boats racing under IRC, YRALIS PHRF, and One Design rules. Boats (except boats of foreign registry) must be enrolled in the YRALIS or another US SAILING association. The Organizing Authority may reject the entry of any yacht that does not in its sole discretion meet the general parameters of the other yachts entered with regard to size or design.

In addition to boats eligible to race in the Fall Series, the Leukemia Cup will be open to boats with or without a valid YRALIS PHRF certificate, sailing on a Navigators Course around government marks. Boats may sail with or without a spinnaker (with the applicable rating) on the Leukemia Cup Navigators Course, and boats without a valid YRALIS PHRF certificate will be assigned a rating by the Organizing Authority.

#### **3 REGATTA WEBSITE**

#### **4 ENTRY**

Online entry is required. Completed entries must be received no later than 1800 on Wednesday, September 20, 2017. Paper entries will not be accepted. Online registration and electronic entry fee payment are available at [www.yachtscoring.com/emenu.cfm?eID=2994](http://www.yachtscoring.com/emenu.cfm?eID=2994).

Boats entered in the Fall Series will also automatically be entered in the Leukemia Cup and given a fundraising webpage. Boats sailing in the Leukemia Cup only must enter on [www.yachtscoring.com/emenu.cfm?eID=2994](http://www.yachtscoring.com/emenu.cfm?eID=2994).

Each boat (except those sailing in the Leukemia Cup Navigators Course) must have a current, valid IRC (Endorsed or Non-Endorsed), YRALIS PHRF, or One Design certificate, as appropriate. PHRF certificates must be available on the YRA website, faxed to American Yacht Club at (914) 967-5340, or emailed to [aycrc@americanyc.org](mailto:aycrc@americanyc.org) no later than 1800 on Wednesday, September 20, 2017. IRC certificate rating information must be available on the IRC website at [www.ircrating.org/racing/on-line-tcc-listings](http://www.ircrating.org/racing/on-line-tcc-listings), or the certificate must be faxed to American Yacht Club at (914) 967-5340 or emailed to [aycrc@americanyc.org](mailto:aycrc@americanyc.org) no later than 1800 on Wednesday, September 20, 2017. Absolutely no ratings or rating changes will be accepted after 1800 on Wednesday, September 20, 2017.

## **5 FEES**

The entry fee is \$225. Completed entries must be received no later than 1800 on Wednesday, September 20, 2017. Entries received after this date will be accepted if they include a \$50.00 late fee.

The entry fee for boats sailing in the Leukemia Cup Navigators Course only will be \$25. There will be no Leukemia Cup entry fee for boats already entered in the Fall Series.

## **6 SCHEDULE**

Races for all classes are scheduled for September 23, 24, 30 & October 1, 2017. More than one race may be held on any day. The first warning signal is scheduled to be made at 1055 each day.

For the Leukemia Cup, a Navigators Course is scheduled for Saturday, September 23rd for boats with or without a valid YRALIS PHRF certificate, or that are not participating in another class in the Fall Series.

## **7 SAILING INSTRUCTIONS**

Sailing Instructions will be available by 1200 on the day before the first race on the regatta website. Changes to the Sailing Instructions will be posted on the regatta website before 2000 on the day before they will take effect.

## **8 VENUE**

Races will be conducted on two separate courses from starting areas located approximately mid-Sound, south or east of Milton Point, Rye, New York. The approximate positions of the starting areas will be announced at 1015 each day for all classes on their respective VHF channels.

## **9 COURSES**

The courses to be sailed will be windward-leeward, Gold Cup, or a course set around government marks. A separate Leukemia Cup Navigators Course will be offered on Saturday, September 23rd with the starting area to be announced on VHF Channel 71 at 0930 that day.

## **10 NOTICES**

Notice to competitors will be posted on the official notice board which is located on the regatta website at: [www.yachtscoring.com/emenu.cfm?eID=2994](http://www.yachtscoring.com/emenu.cfm?eID=2994). The Race Committee will also make courtesy broadcasts on the VHF channels at 0930 on race days.

## **11 ELECTRONIC COMMUNICATION**

Each boat shall carry a radio capable of transmitting and receiving VHF channels 16, 69, and 71. Except in an emergency or to report a protest or withdrawal, a boat shall neither make nor receive any type of electronic communication while racing that is not freely available to all boats.

## **12 CLASSES**

Boats will be placed into classes (designated by numbers 1, 2, 3, etc.) at the discretion of the Race

Committee. A listing of entrants by class and starting area (south or east of Milton Point) will be available on the regatta website by 1200 on the day before the first race and from the Race Committee support boats in the starting areas. Each boat shall display the numeral pennant for its class on its permanent backstay or, in the absence of a permanent backstay, from its stern rail.

### **13 SCORING**

Multiple races are scheduled, where one race is required to be completed to constitute a series. If fewer than 5 races have been completed, a boat's series score will be the total of her race scores. If 5 or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score. IRC classes will be scored using Time on Time. PHRF classes will be scored using the handicaps provided by the YRALIS, and course distance.

For every \$100 raised by a boat participating in the Leukemia Cup Navigators Course (as of 2400 on September 14, 2017) that boat will be awarded a rating adjustment benefit of 1 second per mile towards their finish time in that event, up to a maximum of 20 seconds per mile.

### **14 DINNER**

On the evening of September 23rd there will be a Leukemia Cup dinner and auction. Dinner tickets must be purchased separately for \$100 up until 1800 on Wednesday, September 20, 2017, and then \$125 thereafter. Entrants in the Fall Series or the Leukemia Cup Navigators Course who raise \$500 or more by September 14, 2017 will receive a complimentary dinner ticket. ### **15 PRIZES**

Series prizes for each class will be awarded as follows: a first place prize for two or more entries; second place for four or more; and third place for six or more. The JOYETTE, ZILPH, and CYNOSURE TROPHIES will be awarded to the boats which, in the judgment of the Race Committee, have the best performance in the PHRF, Level, and IRC divisions respectively. The ROGER SHERMAN MEMORIAL TROPHY will be awarded to the boat which, in the judgment of the Race Committee, has the best combined performance in the Spring Series Regatta and Fall Series Regatta. The GERARD T. HANNON MEMORIAL TROPHY may be awarded at the discretion of the Race Committee to a boat or person demonstrating exceptional sportsmanship or fair play. Prizes will be awarded at American Yacht Club after the final race and protest hearings.

The one design class (defined as having its own start) that raises the most money for the Leukemia Cup as of 2400 on September 22, 2017 will be awarded a case of Gosling's Rum to be presented at the Leukemia Cup dinner and auction. A class representative must be present at the dinner to accept the award.

### **16 MOORINGS**

### **17 NAVIGATION RULES**

All boats are cautioned to observe the Navigation Rules of the Road and to yield right of way to vessels restricted in their ability to maneuver, especially to tugs and barges. Any boat observed to impede such traffic may be protested by the Race Committee.

### **18 DISCLAIMER OF LIABILITY/RESPONSIBILITY FOR SAFETY**

By participating in this event and any related activity sponsored or undertaken by American Yacht

Club, the owner, helmsman and each crew member agree: that they understand that sailing is an activity that has an inherent risk of serious bodily injury (including permanent disability, paralysis and death by drowning or otherwise), property damage and other economic loss; that the safety of the boat and her crew and the decision whether or not to start or continue to race is solely their responsibility and at their own risk, see RRS 4 "Decision to Race"; that American Yacht Club and its officers, trustees, members, committees, employees, agents and sponsors will not be responsible for damage to any boat or other property, or to any participant, including injury or death; and that each of them releases and waives all claims which he or she, or any heir, representative, successor or assignee, may have against American Yacht Club and its officers, trustees, members, committees, employees, agents and/or sponsors, arising out of or in any way connected with participation in such race or activity. Assistance, if any, from the race committee or other American Yacht Club vessels, or patrol boats, from any personnel manning them, is at the risk of the participant.
